1. About Dr. Ram Manohar Lohiya National Law University, Lucknow:

All over country, there are 23 National Law Universities (as of now) and Dr. Ram Manohar Lohiya National Law University, Lucknow is one of them. Dr.Ram Manohar Lohiya National Law University was established by an Act of Govt. of Uttar Pradesh in 2005, U.P. Act No.28 of 2005 and came into being on 4th of January 2006 to meet up the new challenges in legal field and to strengthen the vision that was given by the establishment of first National Law School of the country.

2. Purpose of Bid:

Purpose of bid is the selection of service provider for cleaning of PVC and Overhead Water Tank in the University campus.

3. Scope of work:

- I. The bidder will have to do the work of cleaning two overhead water tank and one hundred and seventy PVC Water Tanks installed on the roofs of the University. Detail of the same is available in annexure of 'Scope Of Work'. This work shall be done twice in year in the month of December and June during contract period.
- Cleaning work includes mechanized dewatering, vacuum cleaning, antivacterial spray and ultra violet radiation treatment.

(a) General Information and Instruction to the Bidders:

- 1. E-tender is invited in two bids i.e., Technical Bid (Annexure-A) and Financial Bid (Annexure-B) separately. Manual bids will not be accepted.
- 2. The bidding process is online. Bidder should have valid Digital Signature Certificate (DSC) for online submission of bids. Prior to bidding DSC needs to be registered on the website https://etender.up.nic.in. Tender document may be viewed, downloaded from, and uploaded on the website https://etender.up.nic.in as per schedule given in important date sheet of this tender documenid.
- 3. Please upload only relevant/asked document at required place clearly mentioning the Annexure numbers. Bid containing irrelevant documents may be technically disqualified.
- 4. Bid unaccompanied by requisite earnest money will be summarily rejected. The earnest money shall have to submit in the form of bank draft / bankers cheque which should be in favour of Finance Officer, Dr. Ram Manohar Lohiya National Law University payable at Lucknow. EMD amount shall be 2% of the bid value. Exemption shall be allowed for MSEs/Startups.
- 5. The earnest money will be returned to the unsuccessful bidders after award of contract. EMD to the successful bidder will be returned within 60 days of execution of contract.
- 6. Bidder shall have to quote rates for one time cleaning work including all taxes.
- 7. The successful bidder will be required to submit a Performance Guarantee which shall be 5% of the annual contract value. Performance Guarantee will be accepted either in the



form of bank guarantee in favour of the University or in the form of bank deposit in the University account.

- 8. The bidder will have to present the bill for payment after completing the work and getting it verified from the concerned authorities.
- Provision of all Labour Laws and Regulations of U.P. State and Central Govt. as applicable shall be abided by the Contractor.
- 10. Primarily, the contract shall be a period of one year, which may be extended further period of another two years on the basis of yearly performance of the service provider.
- 11. It must be clearly understood that if the contractor fails to perform the contract and to observe/fulfill any of the conditions thereof to the satisfaction of the University, the contract may be terminated at sole risk and for such action, if any, without prejudicing the right of the administration to forfeit the security deposit.
- 12. The successful bidder shall not sublet the contract to other service provider/agency.
- 13. In case of any dispute in respect of the implementation of contract, the decision of the sole Arbitrator appointed by the University shall be final.
- **14.** Contractor shall be solely responsible for safety of his manpower. They have to be provided safety tackles like shoe, hand gloves, helmets etc for execution of work.
- 15. In case of fetal/non-fetal/accident, all the liability of concerned person shall be borne by contractor only.
- 16. Disposal of leftovers outside the campus shall be the responsibility of the contractor.
- 17. Equipments required for rendering the services shall be the responsibility of the contractor.
- 18. The execution of tank cleaning work will be done by suitable and uniformed hygiene specialist with mechanized equipments, wherever required.
- 19. All the consumables and disposables required for cleaning are to be procured by the contractor. All consumables and disposables should be eco-friendly.
- 20. If work given in the contract is not found satisfactory then proportionate amount will be deducted from the bill of that month. Repeated negligence of any kind can lead to termination of contract. Any loss arises out of this shall be recovered from the security deposited by the Bidder.
- 21. Minimum number of trained manpower including the Supervisory staff required to do the work has to be specified by the bidder in bid.

(c) Cleaning Material and Equipments

Bidder shall have following automatic cleaning equipments for carrying out the mechanical cleaning in the University campus. The successful bidder shall have to make all these equipment physically available in the University before starting the work and these should always remain in working condition:

- 1) Industrial Vacuum cleaners (wet and dry)
- 2) Mechanized dewatering.
- 3) Anti bactirial spray.
- 4) Ultra Violet radiation treatment equipment.
