Candidates seeking admissions in B.A. LL.B. (Hons.) & LL.M. Programme under Foreign Nationals/NRI/NRI sponsored* categories are hereby informed that they may send their willingness to Dr. Ram Manohar Lohiya National Law University, Lucknow through the link given below:

The candidates also need to send a single pdf file of all the enclosures along with the form receipt (which the candidate will receive after filling the above Google form on his/her Gmail id) at e-mail ID admission@rmlnlulaw.ac.in latest by **20th October, 2020**. Willingness received after last date or not in prescribed format will not be considered. Shortlisted candidates, in order of CLAT-2020 All India Rank, shall be called for counseling through online mode on a given date (which is likely to be notified on or before 26th October, 2020). The candidate(s) will be given provisional admission which will be subject to physical verification of their original documents by the University on a given date to be notified later on. **Condition of CLAT-2020 score is not applicable for candidates applying under Foreign National Category.** They may send their willingness directly through above link annexing their proof of identity, document relating to their nationality and eligibility. Candidates are advised to send their complete contact details including their phone number, e-mail ID etc. to enable the University to contact them for further necessary action. The prescribed fee for admission in B.A.LL.B. (Hons.)/ LL.M. programme is given in the Brochure placed on CLAT website. At the time of online counseling, the candidate needs to deposit the first installment of fee prescribed for this category which is given below:

B.A. LL.B. (Hons.)	16	Rs. 40,000/- + \$ 4,000 (Rs. 2,90,400/-) for both SAARC and Non-SAARC countries.
LL.M. (One Year)	05	US \$ 2500 (Rs. 1,81,500/-) for the students from SAARC countries and for Non-SAARC countries it shall be US \$ 4000 (Rs. 2,90,400/-)

Candidates seeking admission under NRI Sponsored category must ensure that the fee is paid from the account of sponsor only.

The candidate is required to be ready with the scanned copies of following documents for online counseling (which is likely to be notified on or before 26th October, 2020):

- a) A certificate showing the NRI status of the candidate (***Annexure-I***) or the NRI status of the person sponsoring the study, in case of NRI sponsored category (***Annexure-II***).
- a. High School/Secondary School Mark sheet and certificate.
- b. Mark sheet and certificate of Intermediate/10+2 examinations.

- c. Mark sheet of final year of B.A. LL.B./ B.A. LL.B. (Hons.), LL.B. or any other equivalent degree from a recognized University in case of LL.M. Candidates.
- d. Conduct/Character certificate from the Institution/University last attended.
- e. Transfer/Migration certificate from the Institution/University last attended.
- f. Soft copy of recent colour photograph of the candidate and signatures of candidate and parents/guardian. (.jpg format)
- g. CLAT-2020 admit card & score card.
- h. Affidavit for the year gap, if any

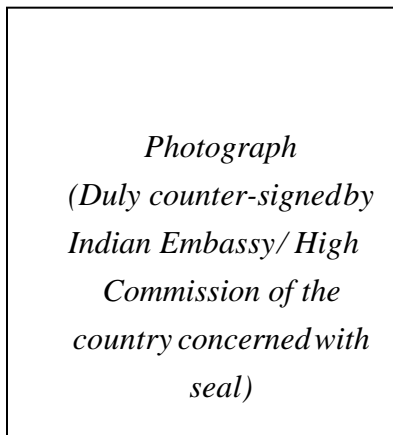

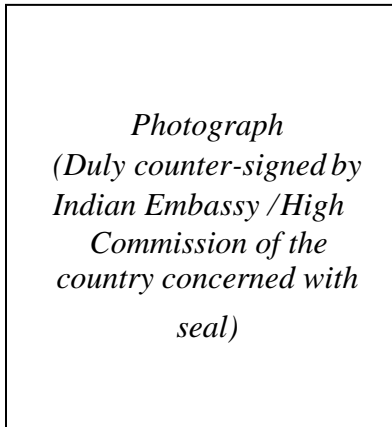
