Admission Notice to the Candidates allotted Dr. Ram Manohar Lohiya National Law University, Lucknow by CLAT Consortium (2021-22) (Revised)

The candidates who have been allotted Dr. Ram Manohar Lohiya National Law University, Lucknow are required to complete the admission formalities through online mode as per CLAT Calendar.

The candidate is required to fill the Application Form through the link <https://forms.gle/myFYU3vGYngKd7zV7>. The candidate is also required to secure the response copy of the submitted google form with him for future use.

INSTRUCTIONS FOR ADMISSION TO THE CANDIDATES (CLAT-2021)

1. Candidates are directed to adhere the schedule as already notified by the CLAT and deposit the **First Installment of Fee (50% of the Annual Fee)** as per following:

Programme Name	Fee to be deposited in addition to CLAT Counseling fee of Rs. 50,000/-
B.A. LL.B. (Hons.)	Rs. 15,000/-
LL.M.	Rs. 1,000/-

The fee must be deposited by using **State Bank Collect** payment gateway through the link <https://www.onlinesbi.com/sbicollect/icollecthome.htm?corpID=288415>. The candidates shall be required to select **Annual Fee** and enter their **Admit Card No. of CLAT-2021 in the column of Enrollment No.** while depositing online fee. Steps for online submission of fee are given below:-

Visit the link given above \Rightarrow Accept terms and conditions and proceed \Rightarrow Select Category \Rightarrow Annual Fee \Rightarrow Course \Rightarrow B.A. LL.B. 1st Year / LL.M

2. The candidate is required to upload the scanned copies of the following documents:
 - a) Proof of payment of Rs. 50,000/- made to CLAT-2021 office towards the counselling fee.
 - b) Proof of payment of Fee made to Dr. RMLNLU, Lucknow.
 - c) Mark sheet and Certificate of High School/Secondary School or any other Equivalent Examination.
 - d) Mark sheet and Certificate of Intermediate/10+2 examinations or any other Equivalent Examination.
 - e) Mark sheet of final year of B.A. LL.B./B.A. LL.B. (Hons.), LL.B. or any other equivalent degree from a recognized University in case of LL.M. Candidates only.
 - f) Conduct/Character certificate from the Institution/University last attended.
 - g) Transfer/Migration certificate from the Institution/University last attended.
 - h) Soft copy of recent colour photograph of the candidate and signatures of candidate and parents/guardian. (.jpg format)
 - i) CLAT-2021 admit card & score card.
 - j) Affidavit for the year gap, if any.
 - k) Valid caste certificate in case of reservation under categories of SC/ST/OBC of UP (OBC caste certificate should not be more than 6 months old as on the date of counseling).
 - l) Certificate applicable in the case horizontal reservation. (please see the note below)

Note:

Candidates who have been offered admission under various reserved categories namely 'SC/ST/OBC/EWS of UP' or 'SAP' or 'Sons/Daughters of Defence Personnel deployed in Uttar Pradesh or Defence Personnel of Uttar Pradesh either retired or killed/disabled in action' or 'Dependents of Freedom Fighters of Uttar Pradesh' will have to attach the scanned copy of original certificate issued by the competent authority in the prescribed format in support of their claims for reservation. OBC students must note that Caste certificate to be provided by them should not be older than **six months**. SC, ST & OBC Caste Certificate must also be verifiable from the website of Board of Revenue <http://bor.up.nic.in>. Dependents of Defence Personnel (Retired, killed or disabled in action) of U.P. should produce certificate issued by 'ZILA SAINIK KALYAN AVAM PUNARWAS ADHIKARI' in support of their claim for reservation.
