Instruction for Payment of Admission Fees:

1. The first installment of annual fee for B.A. LL.B. (Hons.) is \$4000 (Rs. 2,97,560/-) and for LL.M. (One Year) programme fee is \$2500 (Rs. 1,85,975/-) for the students from SAARC countries and US \$4000 (Rs. 2,97,560/-) for Non-SAARC countries.
2. The above stated admission fee has to come from the bank account of the Sponsor for NRI Sponsored candidate or the NRI, as the case may be. At the time of submitting the fees of the sponsored candidate, the sponsor must provide the details of the sponsored candidate (Name, father's name & CLAT-2021 admit card number etc. of the sponsored candidate) to the bank. The candidate, whose fee is transferred through RTGS/NEFT, is directed to send the details of the same at the email id aao@rmlnlu.ac.in.
