

IMPORTANT INSTRUCTIONS
for the candidates of
PG DIPLOMA IN INTELLECTUAL PROPERTY RIGHTS PROGRAMME (2022-23)

1. ELIGIBILITY FOR REGISTRATION:

The Registration to diploma course in Intellectual Property Rights shall be open to the candidates who have obtained the graduate degree in any discipline from any University recognized by U.G.C with not less than 45% of the total marks in aggregate (40% in case of SC/ST).

2. HOW TO APPLY:

- [I] All eligible candidates shall apply in the Prescribed Form on or before **25th October 2022.**
- [II] The fees for the Application Form shall be Rs. 500/- (Rs. 250/- for SC/ST of U.P. candidates). Online Mode/A Bank Draft of the said amount, drawn in favour of Dr. Ram Manohar Lohiya National Law University, payable at Lucknow, shall be attached with the Application Form.

3. SELECTION PROCEDURE

Candidates will be selected on the basis of *inter se* merit prepared according to marks obtained in the graduation.

4. NUMBER OF SEATS:

- [I] The total number of seats in PG diploma in Intellectual Property Rights course will be **Thirty-Eight (38)**. However the course will not run if there are less than 15 students.
- [II] There shall be reservation for eligible candidates in the aforesaid seats for SC/ST of Uttar Pradesh and OBC of Uttar Pradesh as per the UP Government rules.

[I] The duration of the PG diploma course shall be of one academic year.

[II] The classes for the course shall be held in the evening (5.30 PM to 8.30 PM) in the university as per the schedule decided by the university.

[III] **No Hostel facility shall be available to the students of P.G. Diploma in Intellectual Property Rights Programme.**
