## A BRIEF NOTE

Dr. Ram Manohar Lohiya National Law University, Lucknow entered into an MoU with the Additional Director General of Police (Crime), Uttar Pradesh on June 20, 2018 at the Head Quarter of the Director General of Police U.P. in Lucknow with a purpose to set up an institutional mechanism for interaction between University students / researchers and the police officers of the state on legal issues. The MoU will be used to help the police personnel to update their knowledge about legal matters and judgements of the courts. The students will be offered internships at the units of the police departments.

The collaboration will be based on research and development activities and training which will not only involve students and police officers but also the faculty members. The collaboration involves research activities for students and faculties and training for state police officers.

The objectives of the MoU will be realized under an institutional mechanism which is termed as **Police – Academia Interaction Forum.** 

The document was jointly signed by Shri Yashwant Rao, I.A.S., Registrar of Dr. Ram Manohar Lohiya National Law University, and Shri Sanjay Singhal, Additional Director General of Police (Crime), in the presence of Hon'ble Vice Chancellor Prof. Subir K Bhatnagar and Shri O.P. Singh, Director General of Police U.P.





# Memorandum of Understanding

Vice Chancellor, Dr. Ram Manohar Lohia National Law University Lucknow through its Registrar (I/C), duly authorized to enter into and sign Memorandum of understanding on behalf of the Dr. Ram Manohar Lohia

National Law University Lucknow is the SECOND PARTY.

## I. PURPOSE:

The purpose of this Memorandum of Understanding (MOU) is:

- 1. To set up an institutional mechanism for interaction of final year students and suitable students of NLU with police officers of the State on legal matters.
- 2. To help the Investigating officers and Police to updates their knowledge about legal matters and Judgements of Courts.

## **II. OBJECTIVES:**

The objectives of this partnership resulting from the MOU include:

- 1. To set up an institutional mechanism for interaction of final year students and suitable students of NLU with police officers of the State on legal matters.
- 2. Development of a collaborative working relationship between State Police and NLU.
- 3. The collaboration will be based on Research & Development activities and Training which will not only involve students and Police Officers but also faculty members.
- 4. The collaboration involves research activities for students and faculties and training for State Police Officers.

- 5. The Collaboration involves interaction of students with police officers to enhance learning about legal matters, forensic investigations, prosecution and gain field exposure.
- 6. Updating the knowledge of Investigating Officers about legal matters and latest Judgments of Courts related to investigation, prosecution and interpretation of India Evidence Act.

### **III. TERMS OF AGREEMENT:**

- To set up an institutional mechanism for interaction of final year students and suitable students of NLU with police officers of the State on Legal matters. The institutional mechanism be named Police-Academia Interaction Forum (PAIF) with the VC of the University and one more member nominated by the VC as member from Academia. The DGP may himself be part of PAIF or nominate two senior officers as Members. The Director, State Police Academy or head of Police training institute/division may be appointed as the Nodal officer and member from State Police. The Director, State Forensic Laboratory to be a Member of the Forum. The member nominated by the VC of the University may be the Convener.
- 2. The NLU will send the final year students and suitable students of each academic session for one calendar month of internship to the State Police Hqs. The State Police Hqs. will attach the students with Officers in Police Stations for one calendar month. A Nodal Officer may be appointed in each Police Station in this regard.
- 3. At the end of internship, the students will submit report to State Police and NLU. The NLU may grade the internship of the students as part of their internal evaluation/assessment process. The mode of internal evaluation/assessment should be completely decided by the NLUs. After the submission of reports by the students, a workshop may be organized by the State Police wherein the students will present their report and member of faculties of the NLU may also be invited for giving suggestions.
- 4. The State Police will organize visit of the students to Police Training Institutes, State Forensic Science Laboratories, Prison, one Stop Crisis Centres, state legal service authority and any other specialized units of police during the internship period.
- 5. Regular Academic Conferences/Workshops/Discussions to be conducted by State Police and NLUs in a joint collaboration on investigation process, collection of evidence, trial monitoring, coordination, functioning of district prosecution cell, problems, faced by IOs during investigation. The Conferences/Workshops/Discussions will involve the State Police, Forensic Experts, NLU Faculty members and students.
- 6. The NLUs will organize training of Police Officers on legal matters and Judgements of Courts related to investigation, prosecution and interpretation of Indian Evidence Act.
- 7. The Schedule of the internship period will be as follows

1.	Introductory Session- The interns will be introduced to Police Officers/Staff of the Police Station, the area of working and jurisdiction.	1 Day
2.	Assigning Tasks/Projects to (tentative tasks/projects to be assigned are indicated at Section IV,2)	20 days

4.	Internship Report Writing	3 days
5.	Workshop and Valediction	1 days

## **IV. DELIVERABLES:**

- 1. The suggestive list of task which may carried out by the Investigating Officers/ Police Officers during the period of attachment of the students are as follows:
  - a) Each Investigation Officer/Police Officer to review 3 cases after attachment of the NLU students.
  - b) Analysis of crime scene by Investigation Officer/Police Officer based on interaction with students.
  - c) The Investigating Officers/Police Officers to update their knowledge about the possible evidences to be collected.
  - d) The Investigation Officers/Police Officers to update their knowledge about legal matters and Judgements of Courts related to investigation, prosecution and interpretation of India Evidence Act.
- 2. The suggestive list of tasks which may assigned to students during the period of attachment are as follows:
  - a) The students may look into FIRs and analyze whether appropriate sections had been used or not.
  - b) The students may assist Investigating Officers/Police Officers in filling of FIRs.
  - c) Updating Investigation Officers/Police Officers about the evidence which can be used by Investigation Officers/Police Officers to strengthen their investigations.
  - d) Updating Investigating Officers/Police Officers about Judgements of Courts which are relevant to the cases they are handling.
  - e) The student may be given acquitted cases for studying and suggesting remedial measures.
- 3. One Academic Conference/Workshop to be conducted by State Police and NLUs in a joint collaboration on investigation process, collection of evidence, trial monitoring, coordination, functioning of district prosecution cell, problems faced by IOs during investigation. The conference/Workshop will involve the State Police, Forensic Experts, NLU Faculty members and students.
- 4. Half Yearly Training Programs to be organized by NLUs for training Police Officers on legal matters and Judgement of Courts related to investigation, prosecution and interpretation of Indian Evidence Act.

#### **V. OTHER ARRANGEMENTS:**

This MOU does not supersede any existing agreement or arrangement or affect any future agreement or arrangement among the parties and does not affect the ability of the parties to enter into other agreement or arrangement related to this MOU.
