

**Notice for the candidates aspiring for admission under NRI/NRI
Sponsored/Foreign National category**

Candidates aspiring for admissions in B.A. LL.B. (Hons.) & LL.M. Programme under NRI/NRI sponsored & Foreign Nationals categories are hereby informed that applications for admission under this category will be invited after the 21st June, 2018. A notification in this regard will be placed on the University website in due course. The application received before or after the prescribed date will not be considered.

The intake and fee for NRI/NRI Sponsored and Foreign Nationals category is given below:

Course	No. of Seats	Fees
B.A. LL.B. (Hons.)	16	₹ 80,000/- + \$8,000 per annum for both SAARC and Non-SAARC countries.
LL.M.	05	US \$5000 p.a. for the students of SAARC countries and for other Non-SAARC countries it shall be US \$8000 p.a.

At the time of counseling/admission the candidates are required to bring the following documents in original:

- A certificate showing the NRI status of the candidate (*Annexure-I*) or the NRI status of the person sponsoring the study, in case of NRI sponsored category (*Annexure-II*).
- High School/ Secondary school Mark sheet and certificate in support of proof of age.
- Mark-sheet and certificate of Intermediate/10+2 examinations.
- Mark-sheet/ Grade sheet of final year of B.A.LL.B., LL.B. or any other equivalent degree from a recognized university in case of LL.M. Candidates.
- Conduct/Character certificate from the Head of Institution last attended.
- Transfer/Migration certificate from the Institution last attended.
- Affidavit for year gap, if any.
- Five color photographs (02 passport size & 03 ticket size).
- CLAT-2018 admit card & Score Card.
- One set of self-attested copies along with the original certificates/documents as mentioned above.
- Undertaking from the person sponsoring the study that he will continue to sponsor the candidate for the entire duration of the course.

Important Notes:

1. ***As directed by the Hon'ble Supreme Court of India in the Writ Petition (Civil) No. 600/2015, admissions under NRI/NRI Sponsored Category will be subject to the outcome of the writ petition***

- 2. The Candidates seeking admission against these seats will be required to apply directly to the University in the prescribed format along with the supporting documents as per the notification to be placed on the University Website. CLAT-2018 All India Rank will be used for the admission to NRI/NRI Sponsored Category.*
- 3. The fee mentioned above includes hostel accommodation charges also but does not include mess charges. Interested candidates are advised to refer to the University website from time to time. In case of NRI Sponsored Candidates fee should be remitted only from the Sponsorer Account.*

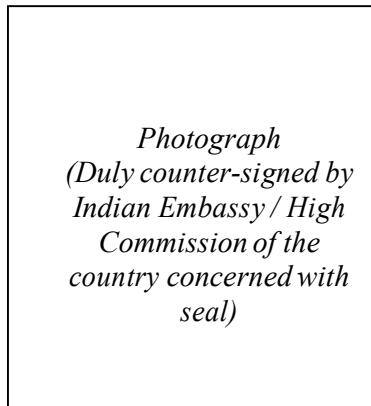

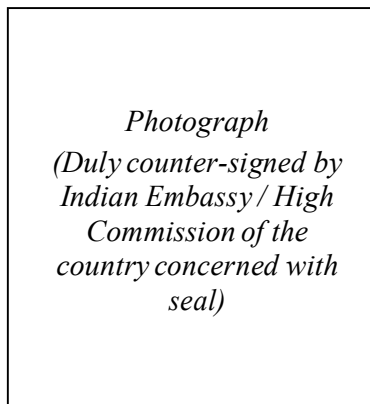
