Payment should be made by using SBI Collect option which is available on University website i.e. www.rmlnlul.ac.in.

- The extra time for depositing the fee given in the column no. 04 & 05 of the above table is being allowed keeping in view the COVID-19 situation.
- The University has allowed the waiver off INR 25920/- for B.A.LL.B. (Hons.) First Year Students and \$346 (Rs.25920/-) for LL.M. students respectively in the column no. 03 of the above table keeping in view of COVID-19 situations.
- The Waiver is till 29.08.2021 but if the University opens for the students earlier than this, the students will have to pay the waived off utility fee from the date university opens.

Note: In regard to NRI/ NRI Sponsored students, if their NRI Sponsors have lost their job or their income get substantially reduced in foreign countries, such existing NRI/NRI Sponsored students can pay their fee from any NRI account in India.

The payment has to come from the account of the Sponsor of the NRI Sponsored candidate or the NRI as the case may be. Sponsor can also transfer the fee of the student in the University account through RTGS/NEFT as per the details given below:
