



**P.G. Diploma Courses Examination Notification, End Term August, 2020.**

In accordance with the guidelines issued by the University Grants Commission regarding conduct of Examination of the students of P.G. Diploma Courses (One Year), under the authorization of the Academic Council of the University, the following modalities for the conduct of Examination have been adopted.

**(i) Evaluation of sessionals**

There will be no marks for Attendance and Class Responsiveness.

**(ii) End Semester Examination**

- a. For each paper 04 (four) questions will be provided by the concerned teachers. Students shall attempt any 02 (two) questions from amongst the 04 (four) so provided. A minimum of 3 (three) questions for long essay shall be from the syllabus which was covered before the classes were suspended due to Covid-19.
- b. For each paper, each question shall carry 50 (fifty) marks and there will be no word limit for the answer submitted.
- c. The students will have to submit their long essay within 48 hours in a hand written form. The scanned copy of the hand written answer shall be sent to the email id of the COE and a copy of the same will also be forwarded by the students to the concerned teacher. The email address of the COE and the concerned subject teacher on which the assignment has to be submitted, will be given in the question paper.
- d. While preparing the final result of the P.G. Diploma Courses students the 50% weightage will be given to the average of the total marks secured in last semester and 50% weightage will be given to the total marks secured in each paper in current semester.

**Note:**

- (i) The other modalities shall be notified separately by the office of Controller of Examination.
- (ii) It is understood that a few students may not be able to appear in the online process due to connectivity issues or other similar reasons. They will be given an offline opportunity in the campus after the re-opening of the University.
- (iii) One opportunity shall be given to the students who appeared in online process and they want to improve their grades in any subject of the current semester after the opening of the University. The mode of the examination will be offline and the marks obtained in the improvement examination shall be "final". This will not be reflected as the second attempt in the marksheet and other official records.
