# **NOTICE**

As per the decision taken at the meeting of the Committee related to Examinations and Academic Calendar Committee and Internal members of the Academic Council dated 19.05.2021, the University has decided to conduct Online-**Repeat Examinations** in the month of June 2021 for the eligible students of all semesters for examinations conducted till **November 2019**.

In the said examinations, **another chance** would also be given to those who could not appear in the examination of **April 2020 (conducted in January 2021)** and of **November 2020** (for which it was resolved earlier that students would be given a chance to appear in the said exam after physical reopening of the University and it would not be counted as repeat).

Apart from it, it is also notified that special repeat examination for final year students would be conducted immediately after the declaration of their result of April 2021 Examination.

## Note:

- 1. All the students who want to appear in the Repeat / Another Chance Exam-June 2021 can apply for said exam through the STAM Portal.
- 2. Applicants for Repeat / Another Chance Exam-June 2021 are required to pay full Fee for the same as mentioned in the Application Form downloaded from STAM Portal.
- 3. It is further clarified that applicants for Another Chance Examination have to follow the procedure as applicable in case of Repeat Examination, though their chance will not be counted as repeat. Also, Another Chance in Examination of June 2021 has been allowed to those only who could not appear in the examination of **April 2020 (conducted in January 2021)** and of **November 2020.**
- 4. Applicants for Repeat / Another Chance Examination June -20121are required to fill the Google form (Mentioned below) latest by 28<sup>th</sup> May,2021.
- 5. The students who cannot appear in the upcoming Online Repeat/Another Chance Examinations, June 2021 must inform the University about the same till 28<sup>th</sup> May2021 through filing the entry in the Google form to avail another opportunity to clear their papers.
- 6. For Semesters other than Final Semester regarding the examination held in February 2021 and April 2021, the repeat, and another opportunity to clear the said exam would be provided in the coming months as per the situation at hand.
