Important instructions to the candidates

1. The top five candidates whose names are appearing in the above lists (B.A. LL.B. (Hons.) & LL.M.) are directed to report to the University for counselling/verification of the documents on **10.07.2018 at 10:30 A.M.** Admission shall be given to the candidates in order of CLAT-2018 merit.
2. The list has been prepared on the basis of willingness received from the candidates and their CLAT-2018 merit. This list is provisional & subject to verification of the claims of the candidates.
3. Shortlisted candidates are also required to bring the following documents in original & one set of self attested photocopies at the time of counselling/admission:

- High School/Secondary school Mark sheet and certificate in support of proof of age.
 - Mark sheet and certificate of Intermediate/10+2 examinations.
 - Mark sheet/ Grade sheet of final year of B.A. LL.B., LL.B. or any other equivalent degree from a recognized university in case of LL.M. Candidates.
 - Conduct/Character certificate from the Head of Institution last attended.
 - Transfer and Migration certificate from the Institution last attended.
 - Affidavit for the year gap, if any.
 - Five colour photographs (02 passport size & 03 ticket size).
 - CLAT-2018 admit card & score card.
 - Resident Certificate of state of Jammu & Kashmir issued by the competent authority.
4. If the shortlisted candidate is found eligible at the time of admission , he/she will be required to pay the following fee instantly:

5. Apart from the above mentioned fee all the candidates must have to deposit ₹ 20,000/- towards partial payment of mess fee for the year 2018-19. The fee must be deposited by using State Bank Collect payment gateway. The link of State Bank Collect payment gateway is available on the University website (www.rmlnlu.ac.in). Fee through State Bank Collect can be paid by using net-banking/Credit Cards of any bank. The candidates shall be required to enter their Application No. of CLAT-2018 in the column of Enrollment No. while depositing online fee.
6. Merely reporting for Counseling/deposition of fee doesn't entitle a candidate for admission. Admission shall be subject to the verification of documents/eligibility conditions. Admission will be given on the basis of CLAT-2018 All India Rank.
