#### **GRADING SYSTEM**

The grading system of the University follows a pointer system which is operative in the manner described herein. Each course is worth 100 marks. The overall structure of the distribution of marks in a theory-based course is such that 30 marks are allotted to various assessments during the semester, while 70 marks shall be allotted for the end semester examinations. Each course carries a weightage of 5 credits. Semester Performance Index (SPI) weighs the average performance in the semester, whereas, the Cumulative Performance Index (CPI) weighs the same across the academic sessions attended/passed so far. A student will be deemed to have completed the requirements for graduation if he/she has:

- a. passed all prescribed courses;
- b. secured CPI > 5.0;
- c. cleared all dues of the University, hostel, library etc.; and,
- d. has no case of indiscipline pending against him. A student with a CPI below 5.0 OR having any pending F grades will not be allowed to graduate.

#### STUDENT COMMITTEES

#### Internship and Placement Committee

The Committee works tirelessly to ensure that students get good internships and placements, which form an intrinsic part of a law school education. The flagship event 'Manthan' invites leading experts and alumni from the legal industry to share their experience on different career prospects. The event serves as a forum wherein the Committee acts as a bridge between the student community and the prospective recruiters and thus helps the students in choosing a career option and also equips them for future challenges ahead.

#### **Cultural Committee**

To promote arts and culture in the University, the committee 'Tehzeeb' organises its flagship event 'Ohr' and the inter-university fest 'Riwayat' annually. The dramatics club 'Naqaab' started under the aegis of the committee has received multiple accolades over the years and performs plays at all the committee events. Celebration of all the festivals is facilitated by the committee to promote and honour the cultural diversity on campus.



#### **Moot Court Committee**



The Committee is responsible for all the mooting activities that are held on campus, and works tirelessly in the direction of promoting a strong mooting culture in the University. Events such as the Concours, University Moot Court Selections and Practice moots are organized for awarding national and international moots to the teams. The flagship moot SCC Online International Media Law Moot Court Competition is also organized annually and has seen increasing participation from Universities all over India, with participation from international universities for the first time in 2017.



#### **Legal Aid Committee**

Access to justice is one of the biggest and most intrinsic problems faced by India today. The Legal Aid Committee was set up as an initiative to resolve this problem and imparts legal aid and undertakes social awareness program. The committee has successfully set up the legal aid clinic under its aegis in association with the District Legal Services Association. The committee also organises RMLNLU National Mediation Competition annually.



#### Journal Committee

The journal committee has been successfully publishing the RMLNLU Journal, the annual flagship peer reviewed Journal of the university along with RMLNLU Law Review Blog. These journals publish articles and research papers of contributors from all over the world on contemporary issues of law. Apart from the said law review, the committee publishes a domain specific journal: The RMLNLU journal on Communication, Media, Entertainment and Technology. The committee also organizes an Intra-College Literary Fest called 'EOS' Whose main highlights are Judgment Writing, Turncoat, Quiz, Treasure Hunt, and Legal Writing Workshops and the RMLNLU International Legal Essay Competition (RILEC).



#### **Debate and Discussion Committee**

The Committee selects students to represent University in the debating events, along with organizing the flagship debate events; namely, Ram Manohar Lohiya Parliamentary Debate and Ram Manohar Lohiya National Hindi Debate. The committee has successfully set up the debating society under its aegis to facilitate debating culture.

#### **Sports Committee**

Sport is an integral part of development of students at RMLNLU. Over the past years the college's athletes and teams have made their mark through various national sports fests. The Committee organizes various sporting events throughout the year on intra and inter university level. 'Aavahan' is the annual sports fest comprising of various indoor and outdoor sports.

#### Student Welfare Committee

Student Welfare Committee aims at avoiding the hindrances that may come in the path of a student's learning process. During the stay of a student in the campus, this committee is responsible for solving all the student's grievances. #### Manthan

Manthan is the flagship event organized by the Internship & Placement Committee annually, wherein leading experts and alumni from Corporate, Litigation and Academia share their experience and views on different career prospects with the student, in order to help them choose a career and formulate their plans accordingly. The event serves as a forum wherein the Committee acts as a bridge between the student community and the prospective recruiters and thus helps the students in choosing a career option and also equips them for future challenges ahead.

#### RMLNLU SCC Online International Media Law Moot Court Competition

Organized by the Moot Court Committee of the University in association with SCC Online, the RMLNLU-SCC Online International Media Law Moot Court Competition is an annual event on campus. It started in 2013 in an attempt to develop research and discussion on Media law, the competition has seen an enormous level of participation from Law Schools and Universities all over India, with participation from international universities for the first time in 2017.

#### Ram Manohar Lohiya Parliamentary Debate

The Debate and Discussion Committee of the University organizes the Ram Manohar Lohiya Parliamentary Debate, which is one of the biggest national level parliamentary debates organized every year. Started in 2013, the traditional 3-on-3 Asian Parliamentary Debate sees lively participation from over 40 teams and 60 adjudicators across India annually, and boasts of an appreciable prize money, great hospitality, and great fun.

#### **RMLNLU** National Mediation Competition

The Legal Aid Committee of the University organizes the RMLNLU National Mediation Competition, which is one of the biggest national level ADR competitions, especially for mediation. The teams participating consist of both mediators as well as clients, with prizes being given out for both the categories. The fourth edition of the Competition was held in February 2018, which saw participation of close to 40 teams.

#### **RECRUITMENT PROCESS**

The Recruitment Process is conducted by the Internship and Placement Committee of the University. It is a holistic process which commences in the month of February, and is aimed at facilitating the reach between graduating students and prospective recruiters. The recruitment process is governed by the Recruitment Process Rules which outline the duties and responsibilities of the Placement Cell, the Students, as well as the Prospective Recruiters. These rules expedite the procedure to ensure optimal flexibility to the students as well as the recruiters.

The recruiters are encouraged to conduct pre-placement talks highlighting crucial principle features of their organisation, job profile, terms and conditions of employment, remuneration and other relevant information. The recruiters are urged to indicate their preferred dates for such talks to the Placement Cell either by e-mail or telephonic communication a week prior to their arrival.

In furtherance of the process, the organisations are requested to register themselves with the Placement Cell with their preferred dates in the final placement schedule, by filling the recruitment form. The recruiters are at liberty to determine their eligibility criteria, and the policy for the screening and recruitment process. Organisations can also opt for telephonic interviews and interviews via videoconferencing, and the Placement Cell shall facilitate their process as and when required. In case the recruiters do not want to conduct a pre-interview screening, the CVs of the interested and eligible students shall be forwarded to them, before the final interview. The Placement Cell works to ensure that final recruitments are conducted in a fair and transparent manner so as to maximize the interest of both the students and the recruiters.

The Internship and Placement Committee can arrange University accommodation at the University Guest House, on prior intimation to the University.
