### OTHER TERMS OF THE TENDER

3. Access to all the contents to all the users will be offered on online as well as offline mode on Samsung or Equivalent Tablet based Device inbuilt with e-book reading facilities like flip through fingers, highlighting features, bookmark, write on screen feature, inbuilt dictionary, copy, download, print and other features. All the contents, including updates will be provided for a 3 year period, after which all the contents will stay for life for the respective users on their tablet device.
4. The name of the specific e-books required along with the author details is mentioned in Annexure-I.
5. The application will be able to support automatic updates on connection with Internet and all content will stay on the application, when being accessed on offline mode.
6. The Service Provider will take all responsibility of providing training to all the users through in house or online mode, as best suited by the users.
7. The successful bidder will be required to ensure supply/installation of the material by 21.04.2017 in order to ensure that the training programme is started on 24.04.2017.
8. Bidders are required to submit an EMD of Rs. 1,00,000/- (Rupees one lac only) through Demand Draft/Bankers cheque drawn in favour of “Dr. Ram Manohar Lohiya National Law University Lucknow”. The EMD of the unsuccessful bidders will be returned on finalization of the contract. The EMD of the successful bidder shall be returned after the supply of the requisite items. EMD of those bidders will be forfeited who fails to deliver the material or fails to honor the terms of the contract after issuance of the supply order.
9. The tender document may be obtained from the office of the University on payment of the processing fee of Rs. 1,000/-. The tender document can also be downloaded from the university website [www.rmlnlul.ac.in](http://www.rmlnlul.ac.in). Bidders using downloaded tender document will be required to enclose a demand draft of Rs. 1,000/- towards processing fee.
10. The bids will be opened on 17<sup>th</sup> April, 2017 at 4.00 PM in the Administrative Block of the University. Representatives of the firms who wish to be present at the time of opening of the bids may remain present.
11. Successful bidder will be required to supply the items as per the requirement within a week of issuance of the supply order. 25% payment of ordered value shall be released in advance along with the supply order rest of the payment shall be released within 10 working days after receipt of the material as per satisfaction of the University.
12. ‘Financial Bids’ of only those bidders who are technically qualified would be opened.
13. The bidder must have a valid TIN No., PAN No. and VAT registration No. Photocopies of these registration certificates are required to be enclosed with the tender document.
14. Bidders are required to submit their bids in two parts (i.e. technical bid **annexure-II** and financial bid **annexure-III** enclosed with this document). Both the bids should be sealed in two separate envelopes. Required EMD must be enclosed with the technical bid.
15. Bidders are required to put both the bids in one big size envelope which is to be superscripted with the “Tender for Supply, installation and updation of e-learning-content solutions” and sent/delivered either by post or by hand so as to reach the office of the Registrar, Dr. RML National Law University, Lucknow on or before 2.00 PM the Monday, the 17<sup>th</sup> April, 2017.

### **OTHER TERMS OF THE TENDER**

16. All firms participating in tender must submit the names of their owners/partners etc. along with the contact telephone numbers.
17. Rates quoted in the bid are irrevocable and should be inclusive of all taxes, charges including transportation of the material to the University site. The University shall not pay any amount beyond the price quoted in the financial bid. Tenderers can withdraw their bids before opening of the tender.
18. Bids received after due date and time will not be considered.
19. Quantities indicated for supply, are tentative there may be increase and decrease by 10% to 20% depending on the requirement. Suppliers will be required to supply such additional quantity at the same rates. Suppliers will have to supply additional quantities at the prices agreed under this tender till one year and no upward revision shall be considered during this period.
20. The Vice Chancellor of the University reserves the right to reject any or all the bids in full or part or not to award the contract to the lowest bidder without assigning any reason. The decision taken in this regard shall be final and binding on all.
21. In case of any dispute arising out of the tender process/execution of the contract, the matter will be referred to the sole arbitrator appointed by the Vice-Chancellor of the University whose decision will be final and binding on the University as well as bidders.
