

**IMPORTANT INSTRUCTIONS FOR
THE CANDIDATES OF PG DIPLOMA IN INTELLECTUAL PROPERTY RIGHT
PROGRAMME (2023-24)**

1. ELIGIBILITY FOR REGISTRATION:

The Registration to Diploma Course in PG Diploma in Intellectual Property Right shall be open to the following candidates:

- [I] He/ She has obtained the graduate degree in any discipline from any University recognized by U.G.C with not less than 45% of the total marks in aggregate (40% in case of SC/ST).
- [II] Admission to the course shall be made on merit prepared on the basis of marks/grades obtained in the graduation.

2. HOW TO APPLY:

- [I] All eligible candidates shall apply in the Prescribed Form on or before **February 29th, 2024**.
- [II] The fees for the Application Form shall be Rs. 500/- (Rs. 250/- for SC/ST of U.P. candidates). A Bank Draft of the said amount, drawn in favour of Dr. Ram Manohar Lohiya National Law University, payable at Lucknow, shall be attached with the Application Form.

3. SELECTION PROCEDURE

Candidates will be selected on the basis of *inter se* merit prepared according to marks obtained in the graduation.

4. NUMBER OF SEATS:

- [I] The total number of seats in PG Diploma in Intellectual Property Right course will be **Thirty Eight (38)**. However the course will not run if there are less than 15 students.
- [II] There shall be reservation for eligible candidates in the aforesaid seats for SC/ST of Uttar Pradesh and OBC of Uttar Pradesh as per the UP Government rules.
