Screening Criteria for various Teaching Positions

1. The details regarding the cumulative score of API/Research Score along with the weightage/points assigned to the various components/criteria, are available on the University's Samarth Recruitment Portal. Candidates having any objections may submit the same, duly supported with all requisite documents, on or before **02 September 2025, by 5:00 PM, via the email ID: recruitment@rmlnlu.ac.in**. Objections received after the stipulated date and time shall not be entertained.
2. The calculation of API/Research Score for the posts of Associate Professor, and Professor has been carried out strictly in accordance with **UGC Regulations, 2018 (Appendix II, Table 2)**.

3. Previous appointments/claimed experience have been evaluated in line with the provisions of the UGC Regulations on Minimum Qualifications for Appointment of Teachers and Other Academic Staff in Universities and Colleges, and Measures for the Maintenance of Standards in Higher Education, 2018, under Point No. 10.0 – *Counting of Past Services for Direct Recruitment*. Such experience is subject to verification upon submission of:
 - i. All valid salary slips from the period of employment; and
 - ii. An experience certificate clearly mentioning the mode of appointment (i.e., that the incumbent was appointed on the recommendation of a **duly constituted Selection Committee/Selection Committee** constituted as per the rules of the respective University) along with proof of pay scale offered during the tenure.
4. Awards have been considered only if they are conferred by **International Organizations, the Government of India, Government of India recognized National Level Bodies, or State Governments**.
5. In respect of Research Papers published in Peer-Reviewed Journals, credit has been assigned strictly as per norms: **15 points for a single author and 10.5 points for each co-author**. Impact factors have been determined on the basis of listings in **Web of Science (WoS)/ Thomson Reuters or Scopus** databases.
6. E-Content and related contributions have been evaluated strictly in accordance with **UGC Regulations, 2018, as specified in Table 2, Serial No. 3(d)**.
7. Candidates who have been found provisionally eligible with remarks shall be considered further only upon submission of all requisite documents on or before **02 September 2025, by 5:00 PM**, via the email ID: **recruitment@rmlnl.u.ac.in**. Any submissions received after the stipulated date and time shall not be entertained.
