1. ID proof

- Admit cards and a valid photo ID proof (Aadhaar card, PAN card, Voter ID, Passport, or Driving License) must be carried for verification.

2. Test Structure:

- The test will consist of **40 Objective-type Questions (MCQs)** of 1 mark each based on the subject applied for, general teaching aptitude, and research methodology.
- Total Marks: 40
- There shall be negative markings of 0.5 mark for each wrong answer.

3. Syllabus Coverage:

- Subject-specific knowledge based on UGC NET syllabus.
- General awareness in higher education, research, and pedagogy.
- Logical reasoning, comprehension, and academic writing.

4. Use of Calculators/Mobile Phones:

- Use of mobile phones, smart watches, calculators, or any electronic devices is **strictly prohibited** inside the examination hall.
- Possession of such devices may lead to disqualification.

- b) For the post of Assistant Professor, the selection process shall be conducted in two parts: (i) short-listing and (ii) Presentation & interview
