About the University

The late eighties saw the beginning of the tectonic shift in perceptions about law as a career -from one of the least attractive to one of the most sought-after. It was a time of hope for the legal fraternity. The concept of a national institution to act as a pacesetter and a testing ground for bold experiments in legal education came up before the Bar Council of India in the context of the Council's statutory responsibility for maintaining standards in professional legal education (under the Advocates Act, 1961). Dr Ram Manohar Lohiya National Law University was established in 2005 by the U.P. Act No. 28 of 2005 of the Government of Uttar Pradesh. It was set up on January 04, 2006, to meet the new legal challenges and strengthen the vision of establishing a national law school in Uttar Pradesh based on the pattern of national law schools in the country.

The University Grants Commission New Delhi has recognized the University under sections 2(f) and 12(b) of the University Grants Commission Act, 1956. It was initially incorporated as 'Dr Ram Manohar Lohiya National Law Institute, Uttar Pradesh.' The word 'Institute' was substituted by 'University' and later by Amendment Act of U.P. Act No. 35 of 2006 on November 17, 2006. This was done to give a comprehensive national character to the Institute on the lines of the other premier National Law Universities of the country. The University has been receiving grants from the Government of Uttar Pradesh, which is committed to provide excellent infrastructural facilities and the best academic environment to advance and disseminate learning and knowledge of the law.

The university aims to enhance the capabilities and skills of students and research scholars to create a sense of responsibility to serve society in the field of law by developing skills in advocacy, judicial and other legal services and legislation. The law must deal with problems of a diverse magnitude, and a student of law, the future Advocate, must be trained in professional skills to meet the challenges of globalization and universalizing law.

In this digital era, our society has been facing various problems and challenges due to social, economic, and political inequalities and technological challenges resulting in various disputes. It demands highly trained and skilled lawyers, judges, and legal professionals to resolve such issues. The University is well-equipped to provide legal education of higher standards to students and researchers so that they may become good lawyers and legal professionals.

Syllabus Updation & Review



A two-days syllabus updation for B.A.LL.B. (Hons.) and LL.M. Courses was undertaken with the help of the External Experts Committee on April 15-16, 2024. All the sessions were chaired by Prof. (Dr) Amar Pal Singh, Vice-Chancellor of the University with Prof. (Dr) V. K. Ahuja, Director, Indian Law Institute, New Delhi and Prof. (Dr) Rakesh Kumar, Department of Law Guru Gobind Singh Indraprastha University, New Delhi. All the faculty members presented their courses to be taught in the monsoon session before the committee for review by the expert panel. These subjects included Administrative Law, Criminal Law, Corporate Law, Constitutional Law, Intellectual Property Rights, International Law & Alternative Dispute Resolution etc.



DPIIT-IPR CHAIR

FORENSICS STANDS WITH "THE TRUTH"

Truth is integral to pursuit of justice but it often differs from one person to another, thereby creating perpetual tussle between "My Truth", "Your Truth" and "The Truth", which often form the crux of judicial proceedings. Justice and truth are intangible identities and inherently pose great challenge for decision making process. In fact, evidence is the baseline for exploring truth, and probity and integrity of evidence becomes paramount for delivery of justice. In life, everybody plays with truth and evidence, challenging judicial system, hence there is need for scientific corroboration of evidence. India has reformed its criminal justice legal framework by introducing paradigm shift from 'punishment' to justice'; since justice, irrespective of time and space, remains paramount necessity for human growth and development.

Forensic evidence, being neutral, braced with scientific validation and reliability, has proved its corroborative credence at

global landscape. Forensic evidence never become party to the lis, and always stand with "the Truth" for ensuring justice, since expert opinion may be used as inculpatory evidence to prove guilt and may corroborate to establish innocence as exculpatory evidence. Forensics, broadly consists of technologies and procedures. The Frye Standard (1913, US Supreme Court) and the Daubert Standard (1993, US Supreme Court) regulate the reliability to validate the technology driven scientific evidence in the courtroom. In modern era, technology component in forensics is optimized and has minimal scope for manipulations. However, for ensuring quality assurance (QA) and quality control (QC), forensics at large involves assembly of procedures to be conducted by various stakeholders such as police, forensic experts etc., where chances of misconduct and malpractices cannot be ruled out. Forensic procedures have different stages such crime scene management, which include identification, lifting, packaging, labeling, transportation, storage etc. of the samples, need to maintain the chain of custody (CoC). Coding and decoding of the samples have utmost consequence for securing the integrity of forensic samples. Thus, the Standard Operating Procedures (SoP) and robust Protocols must be in place. Accreditation of forensic laboratories is the need of the hour.

The legal provisions for expert opinion under the new criminal legislation in India is largely a replica of the old procedural laws. Expert opinion may be provided by the experts from scientific (forensic experts) or non-scientific (art, law, anthropology etc.) domains. It is heartening that new introduced section 176(3) of the Bhartiya Nagarik Suraksha Samhita, 2023 has mandated compulsory examination of crime scene by the forensic expert in those offences where prescribed punishment is either seven years or more. Consequently, the role of forensic evidence gets front seat in criminal justice administration. The new provisions of law necessitate augmentation of resources



both in terms of trained experts and forensic laboratories as well capacity building of various stakeholders of justice system within five years from the date of implementation, precisely till 30 June, 2029. Thus, the future of forensic experts in India seems bright and promising. The forensic professions will be instrumental in providing forensic-aid during judicial proceedings as well.

Interestingly, the term 'forensic' does not figure in the entire set of the Indian Evidence Act (IEA), 1872 nor in Bhartatiya Sakshya Adhinyam (BSA), 2023. There is a dire need to define 'expert' under section 39 of the BSA, 2023, which is replica of section 45 of the Indian Evidence Act, 1872. The expression 'specially skilled' mentioned in these legal provisions has not been defined resulting in conundrum to decide who is an expert. In State of Himachal Pradesh v. Jai Lal [(1999) 7 SCC 280], the apex court elucidated expression 'specially skilled' of s. 45 which entails that an expert must have made a special study or acquired a special experience. Thus, an expert must be skilled with adequate subject knowledge.

Further, junk science & forensic quacks need legal and judicial attention. Various unreliable forensic evidence such as bite mark analysis, blood pattern analysis, hair microscopy has been found to be a potential source of wrongful conviction causing incalculable damage to justice system eroding public trust. Forensic misconduct, especially to support prosecution is yet another global challenge in forensic world. History is rife with live examples like Annie Dookhan, a drug analyst serving at the Hinton State Laboratory Institute in Massachusetts, who was convicted for dry-labbing (preparing concocted expert report without conducting analysis). Other examples include fraud at the Houston Crime Lab in the 2000s, the FBI Hair Analysis Scandal detected in 2015 involving flawed forensic testimonies from the 1980s to the 2000s, the 1997 Shirley McKie fingerprint scandal in Scotland, and the Birmingham Six and Adam Scott cases in the UK. The Anokhilal case (2024, Madhya Pradesh), is a glaring example of forensic misconduct in India where forensic errors led to death penalty being awarded twice in two separate trials due to misinterpreted DNA





evidence. The forensic flaws were uncovered during the third trial, and on March 19, 2024, this case marked India's first DNA-based exoneration.

Cross examination of the material witnesses is the right of an accused under the aegis of fair trial enshrined under Article 21 of the Indian Constitution. Section 328(2), 329(2) and 330(1) of the BSA, 2023 conjointly placed a legal embargo by shortening the fundamental right of the accused. Justice Scalia, in Melendez-Diaz v Massachusetts (2009 US SC), held that all analysts had to appear before court even if they "possessed the scientific acumen of Madam Curie and the veracity of Mother Tressa". Anokhilal also reiterated the need for cross-examination of experts and quality of legal aid. In fact, the legal-aid must be supplemented by providing quality forensic-aid.

Public awareness on forensic science is necessary to enable access to justice to common people. Recent incident of rape with murder of a junior medico at the RG Kar Medical College and Hospital in Kolkata is a gruesome example of forensic ignorance, where media has largely reported gang rape and alleged presence of 150 grams of seminal content collected from the corpse of the deceased prosecutrix during autopsy. Later, DNA established the involvement of only one accused. The author has coined term "Community Forensics" for spreading awareness among common mass on basic nuances of forensic justice, which need attention of the policy makers and the academia. Community Forensic Clinics may be introduced in Legal Clinics in the law schools and other institutions.

Law and forensics are complimentary and supplementary to each other, and same intent must be reflected in the epistemology and pedagogy for legal and forensic education. The author has suggested a concept "LAW with LABS", where students of legal studies must be exposed to handson experience in forensic laboratories; and forensic education must incorporate basic concept of law in conjunction with moot court practice for the experts. The new criminal laws in India acknowledge the pivotal role of forensics in the pursuit of justice; but significant challenges remain to be addressed to judiciously translate the legislative intent.
