ABOUT THE UNIVERSITY

Dr. Ram Manohar Lohiya National Law University was established in 2005 by the Government of Uttar Pradesh under the U.P. Act No. 28 of 2005. The University is recognised by the Bar Council of India and the University Grants Commission. Despite being relatively new, the University has successfully produced skilled, dynamic, and socially responsible legal professionals and has become a leading institution for legal education in the country. The campus is spread over forty-two acres and boasts modern facilities, including the Madhu Limaye Library, which is considered one of the best in the country. Students have access to on-campus and off-campus legal resources and digital databases. The University has also established research centres and societies to promote interdisciplinary research in specific fields of law.

The University offers undergraduate and graduate programs with a total intake of 180 students per year, which includes a five-year integrated B.A. LL.B. (Hons.) program, one-year LL.M. program, one-year postgraduate diploma courses in Cyber Law, Intellectual Property Rights, Media Law, Entertainment and Ethics, as well as a Ph.D. program in Law and Humanities. The learning environment and the blend of core print and electronic research resources make it a world-class law library. The library is a two floor centrally air-conditioned independent building with Wi-Fi environment. The national and international electronic learning resources may be accessed 24x7 from any corner of the university and even from outside the campus through remote access service. The library has its own 'Digital Lab' having 45 high-end all-in-one desktop computers for electronic and online research. The scanning, printing and photocopying facility is also available along with a digital lab. The Lab for differently-abled has also been established in the library to facilitate such students. The plagiarism check service is centrally available in the library to promote research and academic scholarship. The advanced video-conferencing facility is made available in the library to conduct online lectures and academic communication around the globe. Web 2.0 enabled Web-OPAC of the Library is the gateway of information search and access to millions of information contents.

GRADING SYSTEM

The grading system of the University follows a pointer system, which is operative in the following manner:

Each course is worth 100 marks. The overall structure of the distribution of marks in a theory-based course is such that 30 marks are allotted to continuous internal assessment during the semester, while 70 marks are allotted for the end-semester examinations.

Each course carries a weightage of 5 credits. Semester Performance Index (SPI) weighs the average performance in the semester, whereas the CPI weighs the same across the academic sessions attended/passed so far. A student will be deemed to have completed the requirements for graduation if he/she has:

- a. passed all prescribed courses;
- b. CPI > 5.0, a student having any pending F grades will not be allowed to graduate; and
- c. has no case of indiscipline pending against him.

COMMITTEES



INTERNSHIP AND PLACEMENT COMMITTEE

The Internship and Placement Committee is a student-run body working under the guidance of its faculty advisors to help students achieve their true potential. The Committee works towards building new relationships and fostering the existing ones with the corporate world by understanding its changing requirements and matching them with the diverse individual aspirations of the students. It is an integral part of the University's education system and contributes by organising various personality development and awareness programs. It works tirelessly to secure internships and placements for the students, which form an intrinsic part of law school education.



MOOT COURT COMMITTEE

The Moot Court Committee is an official student-run body of members across the five batches of the B.A. LL.B. (Hons.) program. It is entrusted with the responsibility of administering mooting activities and events at the University. The Committee conducts an annual Intra Moot Court Competition for allocating National Moots to interested students. The International Moots, on the other hand, are allotted through Open Challenge Rounds. It also conducts several practice moots for the freshers' batch. In addition, the Committee organises orientations and demonstrative workshops, which assist the student body in getting accustomed to the nuances of mooting.



LEGAL AID COMMITTEE

The Legal Aid Committee was set up in 2009 with a vision to promote legal and social awareness among the sections of society that need it the most. To further its aims, the Committee undertakes various projects such as the Legal Aid Camp, which seeks to help free legal aid and social welfare reach administratively remote areas; LAC- Project Asha, which provides access to free legal assistance to undertrial prisoners; and LAC-Shiksha, which works to fill education gaps within our country. Within its umbrella also falls the ADR Cell, which organises all the ADR initiatives within the University, such as the Intra-University Client Counselling and Negotiation-Mediation Competition, CLINEME. The ADR Cell conducts the University's premier ADR competition, the 2TG-RMLNLU International Mediation Competition. The Committee also works with the University's Legal Services Clinic to ensure access to legal awareness and fair representation for all, and for the organisation of Legal Aid Camps.



SPORTS COMMITTEE

The Sports Committee is responsible for choosing and training the students to represent the University at various Inter College Sports events. This year, a contingent was sent to NLU Jodhpur for their Inter College Sports fest 'YUVARDHA' and bagged the position of Second Runner Ups. Sports Committee organizes the Inter College Annual Sports Fest – 'AAVAHAN', in which our University hosts various law schools and other universities from across the country, aiming to conduct multiple sporting events under several formats over a span of four days.



DEBATE AND DISCUSSION COMMITTEE

The Debate and Discussion Committee has been fostering an active culture of dialogue and discourse within the University since its establishment in 2008. Foremost events organized by the Committee include its flagship tournament for the last eleven years – UP's largest Asian Parliamentary Debate, the RML Parliamentary Debate, a legal—themed niche debate called the Alternative Debate with industry insiders, and the Online RML Pre WUDC British Parliamentary Debate that has been introduced this year, to great success. Events like this witness the quality participation of numerous students, scholars, as well as professionals from across the nation and abroad.



JOURNAL COMMITTEE

It is an essential part of legal education to think independendy and pen them down in a manner that others may have an insight into them. The Editorial team at the Journal Committee publishes two journals RMLNLU Law Review, currently running in ins IVth Volume, and RMLNLU Journal on Communication, Media, Entertainment and Technology Law, presently running in its 11th Volume. The Committee also runs the RMLNLU Law Review Blog to encourage discourse on contemporary legal issues. It also conducts an annual flagship event, RMLNLU International Legal Essay Writing Competition (RILEC) and other workshops. The Committee also runs the online college magazine - The Lohiyan Post and conducts the Annual Literary Festival, EOS.



COMMITTEE TO ORGANISE SEMINARS, WORKSHOPS, EXTRA-MURALS, AND SPECIAL LECTURES

The Committee to Organise Seminars, Workshops, Extra-Murals, and Special Lectures, as its name suggests, has been given the crucial responsibility of organising different types of Academic and Intellectual discussions primarily serving Legal Academia. Notable activities include a symposium on the 'Role of National Educational Policy, 2020' with Deputy Chief Minister of Uttar Pradesh, Mr. Brijesh Pathak as the Chief Guest, a panel discussion on "Revamping the Criminal Law Landscape" with guests Dr. Subash C. Raina and Dr. Sarfaraz A. Khan. Additionally, the committee hosted a special lecture by Mr. Swapnil Tripathi on "The Idea of Separation of Power and Indian Constitution," the 2nd Edition of the National Seminar on Law & Technology, and a conference on 'Institutional Arbitration in India: Challenges and Comparison with International Practices' with the well-known name in the field of arbitration, Mr. Tariq Khan as the guest.



CULTURAL COMMITTEE

The Cultural Committee, Tehzeeb, is the quintessential personification of Lucknow's culture and heritage. Tehzeeb offers a creative space for students to indulge in and showcase their talents. With their celebrations of intra-college events like- Jashn-e-Rang, Bharatotsav, Ohr, etc., the Committee ensures students pursue their artistic passion while celebrating Indian culture as well as global heritage. Riwaayat, the flagship inter-college cultural fest, is a four-day festival witnessing students across the nation interacting and competing under one umbrella. Community Service Day is another initiative of theirs to promote community spirit and to do their part for society.



SOCIETIES

SOCIETY FOR EXCELLENCE IN ARBITRATION LAW

The Society for Excellence in Arbitration Law is an alternative forum aimed at disseminating the discourse of arbitration as a subject matter amongst the students, academics and generally interested fraternity. The society started as a platform by a group of students interested in arbitration law to have thought provoking discussions. It aims at instilling an inquisitive approach in the minds of the student fraternity of RMLNLU to enable them to comprehend the scope of arbitration law through discussions, workshops, conferences, and a scholarly blog.

LEGAL SERVICES CLINIC

Founded in August 2015, the University's Legal Services Clinic, a Regulation 24 body under the National Legal Services Authority, offers free legal aid to the underprivileged as per Article 39A of India's Constitution. Located at the University's entrance, it comprises senior Para Legal Volunteers and junior Trainee PLVs, available daily from 6-8 PM. The Clinic organizes city-wide awareness campaigns about legal rights and handles various cases like labor rights, domestic violence, and property disputes.

PROBONO CLUB

The Pro Bono Club at Dr. Ram Manohar Lohiya National Law University, established in January 2023 under India's Department of Justice Nyaya Bandhu programme, enhances access to justice for the underprivileged. The Club has organized RTI workshops, prison camps, and writing competitions, and aided the District Legal Services Authority. Its goal is to connect people with Pro Bono Advocates for free legal counsel, with Club members assisting in legal research and documentation. Working alongside the University's Legal Services Clinic, the Club strengthens the University's legal aid efforts.

DEBATING SOCIETY ('DEBSOC')

The RMLNLU Debating Society, under the Debate and Discussion Committee, fosters university-level parliamentary debating. This academic year saw the return of offline debates, with the Society training first and second-year debaters in various skills, including motion analysis and adjudication. New members were inducted to broaden participation in RML's debating community. RML students excelled in prestigious international national and competitions, achieving accolades like Open Best Speaker and Open Champion titles, and Best Adjudicator awards. They also served as Core Adjudicators in numerous national tournaments.

KAUTILYA SOCIETY, RMLNLU CHAPTER

The society maintains a blog on public policy, featuring a new blog writing contest this year. It continues releasing Spotify podcasts on legal and policy reforms, including new Criminal Laws. Additionally, the Society hosted a two-day 'Policy Adda' on Gender, Child Offences, and Personal Liberty, and drafted comments on the Uniform Civil Code and Sustainable Finance through Green and Blue Bonds. Collaborating with Dhir and Dhir law firm, it's developing policy papers on various national schemes and AI Regulations. The Society's current focus is an Independent Research Project on rural India's Digital Literacy and infrastructure, with plans for a future 'Book Adda' event.

SOCIAL RESPONSIBILITY INITIATIVES





INCREASING DIVERSITY BY INCREASING ACCESS TO LEGAL EDUCATION, UP CHAPTER

IDIA is an organisation that aims to provide resources and financial assistance to underprivileged students who want to pursue a legal education. The organisation has a chapter in Uttar Pradesh, which has been functional for the past seven years.

The chapter consists of five verticals that sensitise underprivileged students about legal education, select and train students for law entrance examinations, conduct fundraising events, conduct legal awareness sessions in collaboration with NGOs, and nurture IDIA scholars who crack CLAT and ioin National Law Universities. The IDIA UP Chapter has sensitised over 810 students in the current session and has conducted over 450 IDIA National Aptitude Tests (INATs) across the state.

BLOODCONNECT FOUNDATION, LUCKNOW CHAPTER

BloodConnect Foundation is a youthled organisation established in 2010 to address blood shortages in India. They ensure a consistent blood supply to government and private blood banks by providing a 24x7 helpline system and spreading awareness. They also hold voluntary blood donation camps and have established network. youth BloodConnect Lucknow is a strong team that, through collective effort, hard work, and dedication, significantly contributed national effort and the saving around 3000 lives per year by collecting approximately 1,000 units of blood.

MANTHAN

An annual flagship event organized by the Internship & Placement Committee, MANTHAN brings together industry experts to guide students in various legal fields through competitions like Mock Personal Interviews, Group Discussions, and Drafting Competitions.



National Seminar on Law and Technology

Conducted by the Seminar Committee, this event explores the intersection of law and rapidly evolving technology, featuring distinguished guests and discussions on research papers, case analyses, and articles by experts in the field.



RMLNLU International Legal Essay Competition ('RILEC')

The Journal Committee's flagship competition, now in its eleventh edition, collaborates with legal firms like Khaitan and Co. and Nishith Desai Associates, focusing on contemporary international law topics.







RECRUITMENT COORDINATION COMMITTEE





RECRUITMENT PROCESS

Register

The Recruiters are requested to register themselves with the Recruitment Co-ordination Committee through the Placement Cell Email ID with their preferred dates in the final placement schedule by filling out the recruitment form.

Pre-Placement Talks

The recruiters are encouraged to conduct preplacement talks highlighting crucial principle features of their organisation, job profile, terms and conditions of employment, remuneration, and other relevant information. The recruiters are urged to indicate their preferred dates for such talks to the Placement Cell either by e-mail or telephonic communication a week prior to their arrival.

Screening Process and Final Interviews

The recruiters are at liberty to determine their eligibility criteria and the policy for the screening and recruitment process. Organisations can also opt for telephonic interviews and interviews via videoconferencing, and the Placement Committee shall facilitate their process as and when required. In case the recruiters do not want to conduct a pre-interview screening, the CVs of the interested and eligible students shall be forwarded to them before the final interview.

Disclosure of Offers

The recruiters, after the final interview, shall declare the list of shortlisted candidates. This disclosure shall contain the job description, designation, remuneration, location, and other relevant terms and conditions of the employment. Offer letter(s), if any shall then be sent to the 'RCC' - acceptance or rejection of which shall be conveyed by the student directly to the recruiter. Such acceptance and rejection shall be in writing, marking the Recruitment Coordination Committee.
