ORIENTATION FOR THE BATCH OF 2028

A demo moot was conducted, giving the First years their initial insight into the world of mooting. The session concluded with a Question-and-Answer round, addressing queries and concerns, setting a promising tone for an enriching year ahead.

PRACTICE MOOT- 1

The Moot Court Committee conducted the Practice Moot-1 (PM-1) on 23rd July, 2023, an event tailored specifically for first-year students to take the first step towards mooting. This innovative competition deviated from traditional formats by eliminating written submissions, instead, focusing solely on participants' ability to think on their feet and articulate arguments from both sides of a judgment. This event was judged by third year students of the University. The theme for this year's competition was Constitutional Law. PM-1 served as a vital initiation into the realm of mooting, providing a unique opportunity for students to hone their advocacy skills and critical thinking.

As a precursor to the two primary first-year moots, Navitas and Concours, PM-1 aimed to give first-year students a head-start in their mooting journey. The Moot Proposition/Case for Practice Moot-1 was released during the Orientation Session conducted by the Committee, setting the stage for an enriching experience.

The sole purpose of PM-1 was to create an environment wherein students were more comfortable and confident in participating in further mooting events that were to be conducted.

WORKSHOPS

The Moot Court Committee has been at the forefront of organizing workshops to enrich the skills and knowledge of the First-year batch. These workshops are instrumental in preparing them for Moot Court Competitions. One significant workshop, led by Subhi Pastor on the 14th August, 2023, focused on oral rounds and was designed to refine participants' abilities in structuring speeches, presenting arguments effectively, and exhibiting courtroom decorum. Another workshop, held on 18th August, 2023, centred on memorial drafting was guided by Sushmita Sharma. This workshop aimed to enhance drafting skills, covering crucial aspects of memorial creation such as formatting and drafting issues and sub-issues. The participants greatly benefited from the personalized guidance and interactive exercises, enriching their understanding and proficiency in memorial drafting.

For researching using SCC Online, a workshop on 22nd August, 2023, led by Kavya Dwivedi, focused on enhancing legal research skills. Participants learned about Boolean search methods, navigating secondary sources, and maximizing the utility of SCC Online, contributing significantly to their research capabilities. Similarly, a workshop for learning to use Manupatra was held on 22nd August, 2023, by Ishaan Singh, Campus Ambassador for Manupatra, giving valuable insights into utilizing Manupatra for various legal research purposes. Practical demonstrations and clear instructions were highly appreciated.

These workshops collectively played a pivotal role in augmenting the skills and knowledge for the Batch of 2028, preparing them comprehensively for their future Moot Court Competitions.

NAVITAS, 2023

Navitas 2023, organized by the Moot Court Committee, was a Moot Court event aimed at introducing first-year students to the intricacies and practical aspects of Moot Court Competitions. The theme for this year's competition was Constitutional Law, a subject matter fundamental to understanding the broader legal landscape. The moot problem was thoughtfully drafted by Mr. Arnav Mathur and Mr. Abhyuday Pratap, fourth year students of the University.

The competition commenced with the Researcher Test on September 1, 2023, designed to assess the participants' research skills and their understanding of constitutional principles. Following this, the oral rounds were held on September 7, 2023. These rounds provided a platform for the first-year students to showcase their oral advocacy skills, legal reasoning, and ability to articulate and defend their arguments effectively.

The Navitas Moot Court Competition not only served as an educational exercise but also aimed to build confidence and competence among first-year students while showcasing their research and argumentation skills. The participants gained valuable feedback and practical experience from this event.

UNIVERSITY MOOT COURT SELECTION, 2023


The University Moot Court Selection Competition 2023, organized by the Moot Court Committee (MCC), was an intra-event, for the purpose of allotment of National Moots. The competition focused on the contemporary theme of Intermediary Liability and White-Collar Crimes. The Moot Problem was meticulously drafted by Mr. Devanshu Gupta, a distinguished Panel Advocate based in Delhi; and Mr. Shantanu Singh, a legal counsel with the Enforcement Directorate.

The competition commenced with the Researcher Test on September 20, 2023, followed by the oral rounds held on September 23-24, 2023. The event witnessed distinguished judges from the legal field. The event was designed to rigorously test the participants' legal acumen, research capabilities, and advocacy skills. After intense and highly competitive rounds, the team comprising Bhavna Bothra, Maanya Kocher, and Akarsh Anand emerged as the winners. The team consisting of KS Arartik, Ayushi Yeliminati, and Aditya Bhatia were the Runner's up for the competition.

Based on their performances, the participating teams were allocated National Moot Court Competitions, for representing the university at these competitions. This competition not only provided an opportunity for students to hone their skills but also served as a stepping stone for their future competitions.

Concours, 2024

The Moot Court Committee of Dr. Ram Manohar Lohiya National Law University, Lucknow, organized a first-year specific mooting event, "Concours' on 13th-14th January. Concours is a crucial Moot Court Competition that provides a platform for First year student. The problem of the competition this year was drafted by Mr. Abhyuday Jaiswal and Mr. Mohd. Shahis Raini, and oral rounds of the competition were judged by the final-year students of the University.

The competition saw enthusiastic participation from first-year students. This mooting tournament was structured around individual participation, where a contestant can be a speaker, researcher, or both. The moot proposition drafted addressed sensitive topics such as intolerant politics, freedom of speech, media ethics, sexual violence, and the administration of justice. While the researcher's test focused on specific legal cases or moot proposition. Students were assessed on their ability to identify relevant legal issues, conduct legal research using appropriate legal resources, analyse legal precedents and case law, and apply legal principles to the proposition.

The oral rounds were conducted on 13th and 14th January which included preliminary rounds, followed by the advanced rounds and finals. Each participant got the chance to present their arguments in front of a panel of judges. The Final round of the competition was conducted in Moot Court Hall of the University.

Post the Competition the highest ranked speakers and researchers were allotted National Moot Court Competitions via their ranks.
