Important Instructions

- A merit list of the candidates shall be prepared in order of CLAT-2024 All India Rank, which will be used for **current as well as future vacancies**.
- Willingness received after the last date/not in the prescribed format is liable to be rejected.
- 02 Shortlisted candidates have to be present before the admission committee for document verification in the order of their CLAT-2024 All India Rank on **07.08.2024 at 12:00 noon** after the publication of the merit list.
- The candidate(s) will be given provisional admission, which will be subject to physical verification of their original documents by the University on a given date.
- The candidate is required to bring the photocopies along with original of the following documents for Counselling:
 - i. Mark sheet and Certificate of High School/Secondary School or any other Equivalent Examination.
 - ii. Mark sheet and Certificate of Intermediate/10+2 examinations or any other Equivalent Examination.
 - iii. Conduct/Character Certificate from the Institution/University last attended.
 - iv. Transfer/Migration Certificate from the Institution/University last attended.
 - v. Recent colour photograph of the candidate and signatures of candidate and parents/guardian.
 - vi. CLAT-2024 Admit card & Score card.
 - vii. Affidavit for the year gap, if any
- At the time of counselling, if the candidate is found to be eligible for admission in B.A. LL.B. (Hons.), he/she will be required to pay the University Fees as follows:

- The fee must be deposited by using State Bank Collect payment gateway through the link <https://www.onlinesbi.sbi/sbicollect/icollecthome.htm?corpID=288415>. The candidates shall be required to select Annual Fee and enter their Admit Card No. of CLAT 2024 in the column of Enrollment No. while depositing online fees. The steps for online submission of the fee are given below: -

Terms & Conditions of the Provisional Admission

- The admission will be provisional and subject to the verification of all the information/facts given in the candidate's application form. Failure to report on the notified schedule will lead to the cancellation of the candidature for admission.
- Only High School/10th Standard mark sheet/certificate for proof of age and Intermediate/10+2 exam mark sheet/Grade sheet for ascertaining qualifying percentage of marks shall be accepted for B.A. LL.B. (Hons.) Programme. For the LL.M. Programme, the mark sheet/Grade sheet of the LL.B. final year shall be seen to ascertain qualifying marks. No other documents shall be accepted in this regard.
- The admission of any candidate is liable to be cancelled without giving any further notice forthwith or at any time during the period of the concerned course of study if it is found that the candidate has/had produced fake/forged certificate(s)/document(s) or indulged in any act of misconduct/indiscipline/moral turpitude or has/had concealed any other relevant information at the time of seeking provisional admission. Such a candidate is also liable to be prosecuted under the Law of the land besides being debarred from appearing in any of the Entrance Test of the University in future.
- Any attempt by the candidate or anyone else on his/her behalf to influence and/or pressure any authorities/Admission Committee or University directly/indirectly for his/her rules of admission shall disqualify the candidate from admission. Such candidates shall also be liable to be prosecuted under the law of the land.
- The provisional admission of the candidates to the course of study shall be subject to such rules and regulations as may be framed by the University from time to time.

Note: Merely reporting for Counseling/deposition of fees doesn't entitle a candidate to admission. Admission shall be subject to the verification of documents/ eligibility conditions. Admission will be given on the basis of CLAT-2024 All India Rank.
