Counselling/Physical Verification of the documents against the vacant seats in B.A. LL.B. (Hons.) and LL.M. (One Year) Programme

This is with reference to the earlier notification dated 20.06.2024 for willingness against the 09 vacant seats in Unreserved Category, 02 in OBC-UP Category in B.A. LL.B. (Hons.) Programme and 01 seat in EWS-UP category in LL.M. (One Year) programme. The abovementioned vacant seats are inclusive of 01 seat each in the PWD, CDP-UP and DFF-UP under horizontal categories.

After issuing the notice soliciting willingness as above, 05 more vacancies were generated in B.A. LL.B. (Hons.) Programme as 02 students in Unreserved Category and 03 students in OBC-UP Category have withdrawn their admission.

- 4. The candidates are also required to bring the following documents in original & one set of photocopies with them at the time of counselling/admission:
 - i. CLAT-2024 Admit card & Score card.
 - ii. Mark sheet and Certificate of High School/Secondary School or any other Equivalent Examination.
 - iii. Mark sheet and Certificate of Intermediate/10+2 examinations or any other Equivalent Examination.
 - iv. Mark sheet of the final year of B.A. LL.B./B.A. LL.B. (Hons.)/LL.B. or any other equivalent degree from a recognized University in the case of LL.M. Candidates only.
 - v. Conduct/Character Certificate from the Institution/University last attended.
 - vi. Transfer/Migration Certificate from the Institution/University last attended.
 - vii. Recent colour photograph of the candidate and signatures of candidate and parents/guardian.
 - viii. Affidavit for the year gap, if any
 - ix. Valid caste certificate in case of reservation under categories of EWS/SC/ST/OBC of UP (OBC caste certificate should not be more than 6 months old as of the counselling date).
 - candidates who have been offered admission under various reserved categories namely 'EWS/SC/ST/OBC of UP' or 'SAP' or 'Sons/Daughters of Defence Personnel deployed in Uttar Pradesh or Defence Personnel of Uttar Pradesh either retired or killed/disabled in action' (CDP-UP) or 'Dependents of Freedom Fighters of Uttar Pradesh' (DFF-UP) are directed to bring with them original certificates issued by the competent authority in the prescribed format in support of their claims for reservation. OBC students must note that the Caste certificate to be provided by them should not be older than six months. SC, ST & OBC Caste Certificates must also be verifiable from the website of Board of Revenue http://bor.up.nic.in.
 Dependents of Defence Personnel (Retired, killed or disabled in action) of U.P. should produce a certificate issued by 'ZILA SAINIK KALYAN AVAM PUNARWAS ADHIKARI' in support of their claim for reservation.
- 5. At the time of counselling, if the candidate is found to be eligible for admission in B.A. LL.B. (Hons.) or LL.M. programme, he/she will be required to pay the University Fees as follows:

Terms & Conditions of the Provisional Admission

- 1. The admission will be provisional and subject to the verification of all the information/facts given in the candidate's application form. Failure to report on the notified schedule will lead to the cancellation of the candidature for admission.
- 2. Only High School/10th Standard mark sheet/certificate for proof of age and Intermediate/10+2 exam mark sheet/Grade sheet for ascertaining qualifying percentage of marks shall be accepted for B.A. LL.B. (Hons.) Programme. For the LL.M. Programme, the mark sheet/Grade sheet of the LL.B. final year shall be seen to ascertain qualifying marks. No other documents shall be accepted in this regard.
- 3. The admission of any candidate is liable to be cancelled without giving any further notice forthwith or at any time during the period of the concerned course of study if it is found that the candidate has/had produced fake/forged certificate(s)/document(s) or indulged in any act of misconduct/indiscipline/moral turpitude or has/had concealed any other relevant information at the time of seeking provisional admission. Such a candidate is also liable to be prosecuted under the Law of the land besides being debarred from appearing in any of the Entrance Test of the University in future.
- 4. Any attempt by the candidate or anyone else on his/her behalf to influence and/or pressure any authorities/Admission Committee or University directly/indirectly for his/her rules of admission shall disqualify the candidate from admission. Such candidates shall also be liable to be prosecuted under the law of the land.
- 5. The provisional admission of the candidates to the course of study shall be subject to such rules and regulations as may be framed by the University from time to time.
- 6. Admission of the eligible candidates for the Specially Abled Person (SAP) category shall be made only based on the certificate issued by the competent Medical Authority.

Note: Merely reporting for Counseling/deposition of fees doesn't entitle a candidate to admission. Admission shall be subject to the verification of documents/ eligibility conditions. Admission will be given on the basis of CLAT-2024 All India Rank.
